1. Public comment

2. Review of past minutes- April 2021
Joann had minor comment. Joann moved, Nadine second.
Brian summarized the Earth Day tree planting event.
3. Administrative Issues (Friedlich-Chandler)-
 - a) ERI Update / Mapping
ERI draft is close to being completed. Kit Chandler recommending having a sit-down meeting to help get the ERI over the finish line. Once the draft is completed, we should insert the maps in and send it to the Watershed for input. Kit Chandler will schedule a sit-down meeting.
 - b) Plastic Ban Education/Outreach
Kit to send the list of businesses to contact for outreach (37 total) developed by Econ Dev Comm. Single use plastic and paper bags, polystyrene food containers.
4. Borough Council Report (Chandler)-
 - a) Updates on Landfill Property and Arboretum
Supplemental funding came through. However, it does not look like the consultant will make the September goal. Currently do not know the extent of wells that will be needed for additional work. Timetable TBD.
 - b) Other issues
Borough is moving to 1x week, large can, trash pickup. There was a complaint to Council that larger households would like the option for multiple pickups per week. Council is evaluating

options. Good opportunity for education on waste management. Partner with library? Post on website? Green Team recorded Journey to Zero Waste. Link on website? Are there opportunities to collect/store recyclables for periods of time? Green Team has discussed idea of a “recycling depot.” How does the Borough spend the \$\$ it gets from the state for recycling? Can we have a broader discussion about the Borough’s efforts? Can we focus on waste reduction and composting?

Question from Nell Haughton (public): How do you get on the Green Team? Is there any way to find out if companies can use the plastic refuge to create products? Does Terracycle reuse plastic?
