BOROUGH OF PENNINGTON RESOLUTION 2008-4.17

RESOLUTION AMENDING THE CONSTRUCTION RULES AND REGULATIONS OF THE PENNINGTON BOROUGH WATER AND SEWER DEPARTMENT PERTAINING TO WATER SERVICE

WHEREAS, the Pennington Borough Water and Sewer Department is responsible for the enforcement of standards for the installation, maintenance, repair and replacement of all water meters in use in the Borough;

WHEREAS, Borough Council has introduced an ordinance prescribing means to ensure that water meters are installed, maintained, repaired and replaced in accordance with the Rules and Regulations of the Pennington Water and Sewer Department, which shall be consistent with State regulations and applicable standards of the American Water Works Association (AWWA), as determined by the Borough Engineer;

WHEREAS, pertinent rules and regulations of the Department include "Construction Rules and Regulation - Application and Design Instruction" and "Construction Rules and Regulation - Standard Details," both effective December 2000;

WHEREAS, the Borough Engineer has prepared amendments to these rules and regulations, consistent with State regulations and AWWA standards, which (a) prescribe a standard form of application for water service and a related checklist which, among other things, will assist in the sizing of water service lines and meters in accordance with uniform standards, and (b) provide detailed sketches of standard design details for a range of different water service installations and meters;

WHEREAS, Borough Council seeks to adopt and approve these amendments and the Rules and Regulations of the Department as so amended;

WHEREAS, Borough Council also seeks to ensure that the Rules and Regulations of the Department are consistent with State regulation and applicable industry standards as determined by the Borough Engineer;

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Pennington, that the Construction Rules and Regulations of the Pennington Borough Water and Sewer Department are hereby amended as follows:

- 1. The rules and regulations entitled "Construction Rules and Regulation Application and Design Instruction" are amended to include the attached "Water Meter Installation Checklist" and application form prepared by the Borough Engineer, Van Note-Harvey Associates.
- 2. The rules and regulations entitled "Construction Rules and Regulation Standard Details" are amended to include the attached drawings described as "Borough of Pennington, Pennington Water Company, 'Water Meter Installation Standards'" and having the following respective titles:
 - a. "Typical Domestic Water Service Installation," Drawing 1;
 - b. "Typical Domestic Meter 'Inside Installation' 5/8" thru 1"," Drawing 2;
 - c. "Typical Domestic Meter 'Pit Installation' 5/8" thru 1"," Drawing 3;
 - d. "Typical Domestic Meter 'Inside Installation' 11/2" 2"," Drawing 4;

- e. "Typical Domestic Meter 'Pit Installation' 11/2 2"," Drawing 5;
- f. "Typical Compound Meter Installation 3" 6", Drawing 6;
- g. "Detail For Remote Wall Box Installation For Meters In Pits 11/2" And Larger," Drawing 7;
- h. "Typical Turbo Meter Installation 3" 16"," Drawing 8;
- i. "Typical Independent Fireline And Domestic Services," Drawing 9;
- j. "Typical Combined Fireline And Domestic Services," Drawing 10-A;
- k. "Fire Service Assembly Meter (For Both Domestic & Fire Service Through A Single Water Service Line)," Drawing 10-B;
- 1. "Typical Pit Installation' Meters 3" And Larger Fire Line Services," Drawing 11;
- m. "Typical Domestic Meter 'Pit Installation With Remote' 5/8" thru 1"," Drawing 12;
- n. "Typical Domestic Meter W/By-Pass Piping 'Inside Installation' 11/2" 2"," Drawing 13;
- o. "Bilco Type J Sidewalk Door Model J-2AL Detail," Drawing 14.
- 3. To the extent of any inconsistency between existing rules and regulations of the Department and the above Checklist/application form and described Drawings, the latter shall govern.
- 4. The Construction Rules and Regulation of the Department, with respect to both Application and Design Instruction and Standard Details, are amended to include the following provision of general application:

"These Rules and Regulations incorporate all applicable State Regulations. Construction of these Rules and Regulations shall be consistent with State Regulation and applicable standards of the American Water Works Association, as determined by the Borough Engineer."

5. A copy of the rules and regulations of the Pennington Water and Sewer Department shall be made available for public inspection during normal business hours in the Office of the Superintendent of Public Works.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Construction Rules and Regulation of the Water and Sewer Department as amended herein are approved and ratified.
