Details: On July 25,2023 at approximately 6:45pm P.O. D'Ascoli responded to a residence located on Walking Purchase Drive for a report of Identity Theft. Upon Officers Caruso's arrival he was met by the resident who stated that she had received a call from an unknown male actor who claimed to work for "Apple". The male told the victim that her computer had to be updated and the victim in return gave the male actor a lot of personal information. The victim realized that she was being scammed and was able to contact her bank and credit cards and have all fraudulent transaction reversed and the accounts frozen. This is currently still being investigated.

Type of Incident: Theft / Burglary

Investigating: P.O. Crauso

Details: On August 19, 2023 Officer Caruso was dispatched to two different addresses. The first address being a Vannoy Avenue residence and the second being a Sked Street residence for the report of a bikes that were stolen. Officer Caruso took the theft for both victims and cleared the residence.

A short time later Officer Peterson and Officer Pauciullo of the Hopewell Township police department noticed two (2) males riding bikes on Diverty Road. These subjects and the bikes fit the description that P.O. Caruso passed on. After further investigation, a juvenile and an adult male were placed under arrest. The adult was charged accordingly and was also found to have an active NCIC warrant for his arrest. He (The adult) was processed and then transported to Bergen County Jail by the Mercer County Sheriffs where he was lodged on the warrant. The juvenile was released to a parent. Further charges may be issued pending the police investigation.
